TERMS OF USE AND PRIVACY POLICY

You hereby declare that you have read the terms and conditions set out in this text and accept the terms of use and privacy policy by using the website and mobile application created and made available for the provision of online visa appointment services ("Service") by Gateway International Visa ve Danışmanlık Hizmetleri AŞ ("Gateway") and uploading the documents based on your application to the system.

Gateway may change and update the terms and conditions contained herein from time to time without prior notice, so please continue to review this text when you access the site and/or mobile application. If you do not agree with any changes to the terms of use, you may choose to deactivate your account and not use any functions related to the service that will be made available to you.

Please read these Terms carefully before applying online or using the Service. You should read the entire terms as this is a legally binding text and contains information about your legal rights. These terms and conditions tell you who we are, how we will provide our services to you, and other important information about the online appointment. Failure to meet and/or comply with the terms and conditions set out in this text and/or failure to follow the current notifications/changes may result in the rejection and/or delay of your visa application, so you must follow the steps in your application carefully. Otherwise, Gateway assumes no legal, administrative and criminal liability.

A. TERMS OF USE

a. PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE USING THE WEBSITE/MOBILE APPLICATION.

- 1- These terms are for the Service offered subject to your acceptance of all of them without change, and by using these terms, you acknowledge that you accept, and agree to be bound by them unconditionally. If you do not agree and/or meet these terms, you must not use the service.
- 2- Citizens of foreign countries recognised by the Republic of Türkiye have the right to make online appointments. If you do not have a valid passport from one of these countries, you may not be able to finalise your application. Please check whether you have a passport from one of the valid countries.
- 3- The Republic of Türkiye has the right to change the requirements for online appointments and the nature of the information and documents required without prior notice, and such changes take effect immediately. Therefore, it is your obligation to check whether you have provided the necessary information and documents for the online appointment before your application.
- 4- For Gateway is only the party providing the Service in the applications to be made by you, and receipt of an online appointment does not involve a decision regarding the acceptance/rejection/refusal of your visa application, the Republic of Türkiye has the sole power to decide on your application.
- 5- Since the exclusive power regarding your entry into the Republic of Türkiye is held by the Republic of Türkiye, and the competent authority appointed by it in accordance with the legal legislation, it is possible that your entry into the Republic of Türkiye may be refused despite the approval of your visa application after the online appointment you have made using the service. - 7- As the applicant, you are responsible for checking the online appointment confirmation processes. It is therefore important to be sure about your choice of date and branch before your appointment. Otherwise, you may not be able to either update or cancel your appointment.
- 12- While receiving the service, you may need to follow the notifications to be made to you, and to provide the necessary updates within the scope of these notifications without delay. If you fail to comply with such notices and instructions duly or in a timely manner, you may not be able to continue with your appointment, and/or your appointment may be cancelled.
- 13- Gateway reserves the right to change the terms and conditions on the website and mobile application. Each time you want to use the Service, please check the terms to make sure you understand the terms that are currently in effect.
